

**The "SAW II"/HALLOWEEN COSTUME WAREHOUSE Sweepstakes (the "Sweepstakes") is intended for viewing and participation only in the 50 United States and the District of Columbia ("U.S.") and shall be construed according to, and governed exclusively by, U.S. law. **PROMOTION DESCRIPTION:** The Sweepstakes begins on or about 12:01 am Eastern Standard Time (EST) on October 1, 2005 and ends at 11:59 pm EST on November 1, 2005 ("**Entry Period**"). By participating in the Sweepstakes, each entrant unconditionally accepts and agrees to comply with and abide by these Official Rules and the decisions of Lions Gate Films Inc. ("**Sponsor**"), which shall be final and binding in all respects.

**ELIGIBILITY:** This Sweepstakes is open only to individuals who are (i) legal residents of the 50 United States (and the District of Columbia), located in the U.S. at the time of entry, and (ii) age 18 or older at the time of entry. All required information must be completed to enter and to be eligible to win. Incomplete entries will be disqualified.
